

Report of the Parish Assembly 2018

Monday 16th April 2018, 7.30pm Tap Room, New Inn

1. WELCOME & APOLOGIES

The Chairman welcomed everyone to the Assembly and noted the lack of public attendance. Apologies received from County Cllr David Simpson, Ward Cllr Anne Crampton; PCSO Nick Greenwood, Frazer Hamilton

2. RSPB UNDATE ON HAZELEY HEATH

The Chairman thanked Mike Coates from RSPB for giving his time to present an update on Hazeley Heath.

i Fencing Application approved

Mike reported that the Common Land planning applications CL 49 and CL 100 for fencing and associated works on the Heath received approval on 15th April. Work will commence in September at the end of the breeding seasons.

ii Funding

The current High Level Sustainable Finance funding ends in February 2019. Good news is that Natural England and the Rural Projects Agency have expressed satisfaction with the project progress and so new funding is in place. Bad news is that the new scheme funding can't be accessed until the beginning of the next calender year 1st January 2020, giving an 11 month funding gap. Alternative funding sources are being considered.

iii Birds

Notable bird species are doing reasonably well despite the weather. Dartford Warbler numbers are stable, Wood Lark slightly down, Night Jars not yet returned.

iv **Butterflies**

March *Whitewater Magazine* featured an article from Mike on the Silver Studded Blue and Grayling. Hazeley Heath is an 'exemplar' site for butterfly management and hosting training days for other Heathland managers.

v Reptiles

There has been an increase in the documented numbers of young adders but this may be due to more sites being surveyed. (Tin trays are put down and as heated by the sun the snakes bask beneath them.) Two young adders were found in 2014, nine last year.

vi School visits

Mike described a very successful visit by a local school, but then said this is only for Hartley Wintney schools as lack of parking requires walking distance.

He was trying to improve communication as an ongoing process – articles in the *Whitewater Magazine*, via the Parish Council, the Consultative Group included representatives from the Commoners and from the Parish Council. Also the events and guided walks (though unfortunately no discounts for residents).

3. Re the parking provision opposite Arrow Drive. Four-by-fours often park so that few others can. HGVs use the lay-by for overnight parking.

4. Speeding traffic on B3011

Mike agreed with the problems of speed on the B3011 and commented on Highways reluctance to reduce the speed limit. It was generally agreed that incidents should be logged whenever possible. Most accidents are not reported.
